Ans- The Visa on Arrival facility is only for the nationals of Japan, South Korea and UAE (only for such UAE nationals who had earlier obtained e-Visa or regular/paper visa for India). For the nationals of all other countries eligible for e-Visa, the e-visa application have to be filled online and the applicant must wait till the confirmation/Grant of ETA for travelling to India. All foreign nationals entering India are required to possess a valid international travel document in the form of a national passport with a valid visa from an Indian Mission/Post or eVisa (Limited Categories) from Bureau of . Other people can assist you with your visa application. Note that under U.S. law (22 C.F.R.) you must electronically sign and submit your own application unless you qualify for an exemption. Even if someone else helped you complete the application, you (the applicant) must click the "Sign Application" button, or your application may not be accepted.

Instructions. A. Online application Form: This application form is meant for those foreigners who are applying for visa from outside India; Each online application form is meant for one person only. Separate application has to be filed for each applicant. Instructions. It would be ideal if you read the guidelines precisely before filling in the application shape. The E- Visa is for International Travelers whose only purpose of visiting India is recreation, tourism, meet family or friends, seeking medical treatment or a business visit. All U.S. citizens require a valid Indian visa to enter and exit India. For visitors who are traveling to India only for tourist purposes and plan to stay fewer than 60 days, the best option is to apply for an e-Visa online, which you must do at least four days before you leave for your trip. At the top of the online India Visa Application you will see a Temporary Application agojuye.vestism.ru sure to record and save the Application ID. If you exit the form without clicking "save and continue", or if you do not keep the Application ID, your information will be lost. Instructions for evisaIndia. Legitimacy for e-Visa. e-Visa is valid for 30 days to 1 year depending upon purpose of agojuye.vestism.ru visa must be availed within its period of validity. The e-Tourist visa and e-Business Visa will be legitimate for one year from the date of grant of ETA. Nonstop remain amid each visit on an e-Tourist visa must not surpass 90 days, aside from natives of Canada, Japan, United Kingdom and United.
